4. undertaking training and updating actions for school staff on the subject of digital skills in order to implement and consolidate effective teaching practices with the use of new technologies, also useful in periods of health emergency, to support the learning

#### The family is committed to:

- 1. viewing the school information on the institutional website and to keep constantly informed on the topic;
- 2. sharing and support the indications of the school, in a climate of positive cooperation, in order to guarantee the safe developmet of all school activities;
- 3 . systematically and daily monitor the state of health of their children and other family members, and in the case of symptoms referable to COVID-19 (fever with a temperature above 37.5 ° C, chills, dry cough, exhaustion, soreness, muscle aches, diarrhea, loss of taste and / or smell, difficulty in breathing or shortness of breath), keep them at home and immediately inform your family doctor or emergency medical service following the instructions. The IIS COVID-19 report n. 58/2020 stresses that, if a pupil or a school operator is living with a case, it will be considered close contact and quarantined even in the event of an ascertained positivity of a family member, upon evaluation of the DdP.
- 4. going immediately to school and take your child away in case of sudden onset of symptoms referable to COVID-19 in compliance with the Regulations containing measures to prevent and contain the spread of SARS-CoV-2;
- 5. notifying the school of the absences of their children for health reasons and follow all the procedures set out in the ISS COVID-19 Report n. 58/2020 (the updated versions of these reports and the extracts of particular interest to families are published on the institutional website);
- 6. contributing to the development of personal autonomy and pupils' sense of responsibility and promoting a correct behavior towards the measures adopted in any area to prevent and contrast the spread of the virus, including the timely compliance with entrance times, school leaving and attendance of their children to educational activities both in presence and (possibly) at a distance.
